Shari Levy, a distributee of the decedent and an objectant to probate of the instrument dated June 8, 2006 seeks an Order granting her limited letters of administration in order to pursue the turnover of assets of the decedent alleged to be held by the preliminary executor in her individual capacity, members of the preliminary executor's family, and others. The preliminary executor Sandra Barrera objected to the application on the record although she failed to file any objections and seeks an adjournment for the purposes of bringing a motion to dismiss.

After a Hearing at which both parties were given an opportunity to be heard, the respondent's application for an adjournment is denied as the Court finds that the allegations in the proposed motion to dismiss do not constitute a valid defense to this application, and the petition for an Order granting limited letters of administration pursuant to SCPA 702(9) to Shari Levy is granted.

Limited letters of administration shall issue to Sharl Levy upon her duly qualifying.
